#### Market-making Trading Business of Stocks on STAR Market is Officially Launched

October 28

With the approval of the China Securities Regulatory Commission (CSRC), the first batch of STAR Market makers will officially launch the market-making trading business of stocks on the STAR Market on October 31, 2022 (Monday). The introduction of market maker mechanism on the STAR Market is an important measure to constantly improve the basic system of the capital market and further play the role of "pilot zone" of STAR Market reform. For the construction of the STAR Market, it helps improve the liquidity of stocks, release market vitality and enhance market resilience. For investors, it helps reduce transaction costs and improve market pricing efficiency. For deepening reform, it is another useful practice to comprehensively promote the high-quality development of the STAR Market and build a capital market with Chinese characteristics.

In order to guide shareholders of STAR Market companies to transfer in an orderly manner in compliance with laws and regulations, introduce institutional investors to undertake investment, and better maintain market order and protect investors' interests, the SSE revised relevant rules to optimize the relevant operating procedures and information disclosure requirements for price-inquiry transfers on the STAR Market, and coordinated matters including the window period regulations and the application of depository receipt rules.


According to the Implementation Measures of Shanghai Stock Exchange for the Shanghai-Hong Kong Stock Connect Business (hereinafter referred to as the Implementation Measures) and other business rules, after shifting from secondary listing to primary listing in Hong Kong, WVR companies can be inspected on the inspection date in accordance with these rules. Those that comply with Article 65, Article 66 and Article 67 of the Implementation Measures can be included in the HKSC.


#### Shanghai A Shares (Main Board A & STAR Market) Market Cap & Trading Value

#### **Index Performance & Equity Trading Value**







#### Monthly IPO Proceeds (RMB bn)



#### **STAR Market Sector Distribution**




#### **STAR Market IPO Pipeline**



Daily Northbound Trading Value and Net Inflow (RMB bn)




#### Monthly Northbound and Southbound Net Inflow (RMB bn)

#### Monthly Total Market Value and Average Daily Trading Value (RMB bn)



#### Monthly Total Market Value and Average Daily Trading Value (RMB bn)


