#### CSI Carbon Neutral 60 Index (931772) Was Officially Launched

November 9

The CSI Carbon Neutral 60 Index (931772) was officially launched on November 9. The Index selects 60 securities of listed companies from deep low-carbon field such as clean energy, energy storage and so on and high-carbon reduction field such as thermal power, steel and so on as index constituents. The index is to measure the performance of securities which have great contribution to carbon neutrality.

Last month, the CSI became the first domestic index provider whose ESG index is recognized to be compliant with the IOSCO Principles for Financial Benchmark.







STAR Market Sector Distribution (No. of listed companies in the sector)


