

Monthly Review

- 5 companies listed on SSE in September, of which 3 are from strategic emerging industries, specializing in artificial intelligence, pharmaceuticals and specialty chemicals.
- SSE held the 4th corporate access event for foreign investors. Around 20 institutional investors visited 6 SSE listed companies during the two-day event.
- SSE and Moscow Exchange co-held the 4th China-Russia Capital Forum in Moscow and St. Petersburg.
- SSE signed a tri-party agreement with Luxembourg Stock Exchange and Bank of China to further develop the Green Bond Channel project.
- SSE and SZSE co-held the 2018 International Seminar on Front-line Regulation by Stock Exchanges.
- On September 27, FTSE Russell announced to include China A Shares into its Global Equity Index Series in June 2019.





SSE Composite & Daily Turnover




Monthly Turnover




Market Cap. & No. of Listed Comps



Monthly IPO




No. of New A Share Accounts






Derivatives Market (SSE 50 ETF Options)

Daily No. of Contracts Traded




Monthly No. of Contracts Traded (since launched)



Daily Turnover


