

Monthly Review

- 14 companies listed at SSE in July, of which 8 are from strategic emerging industries, specializing in new energy, biopharmaceuticals, high-end equipment manufacturing, and etc.
- SSE launched the first batch of asset-backed securities for PPP-funded projects under the Ministry of Finance.
- SSE successfully carried out the pilot trial to allow individuals to buy local government bonds.
- CSRC released *Report on Regulation over Listed Companies' Implementation of Accounting Standards in Annual Reports, 2016*.
- CSRC said that stricter rules on stock trading suspensions have taken effect. In 2016, both the number and the duration of suspensions decreased significantly compared to those in 2015.

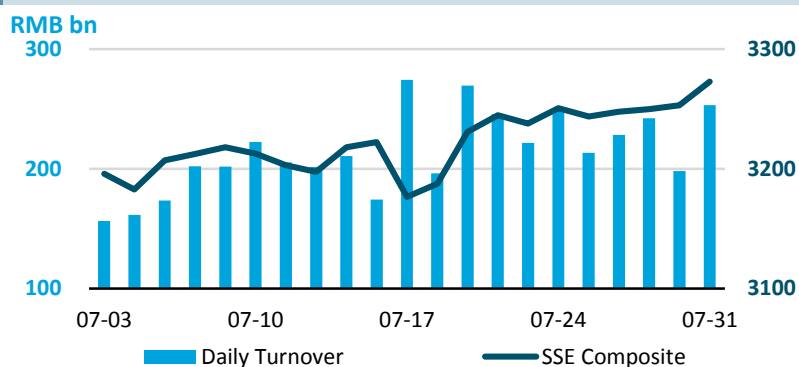

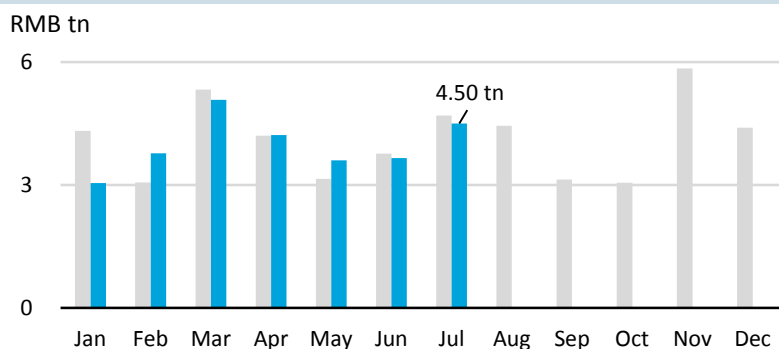

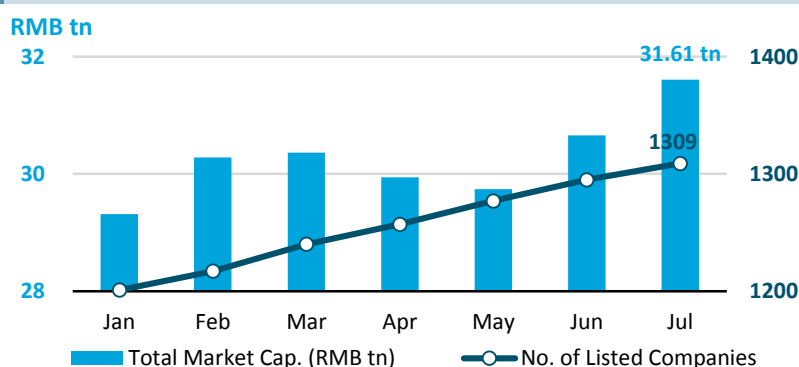
SSE Composite & Daily Turnover



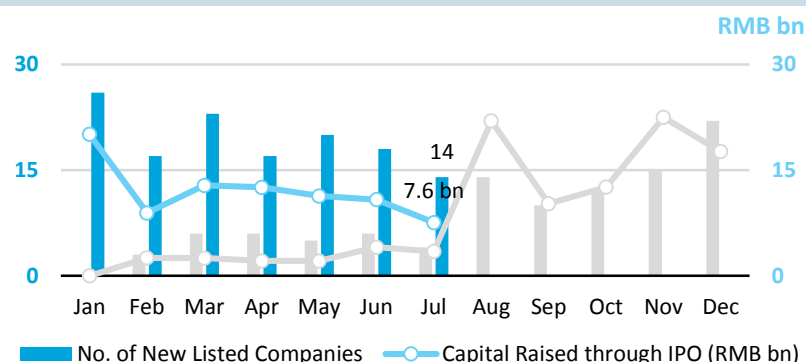
Monthly Turnover



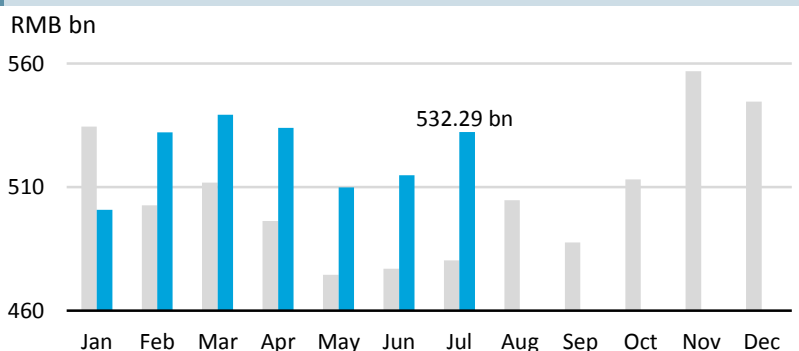
Market Cap. & No. of Listed Comps

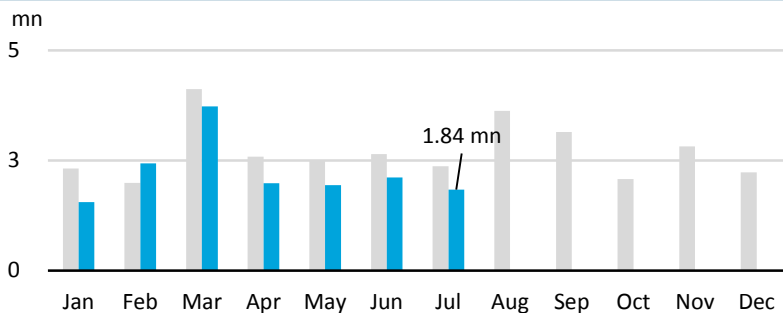


Margin Financing & Securities Lending Outstanding



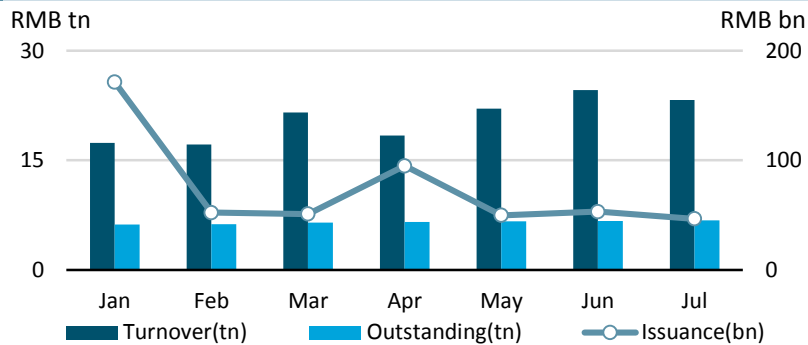

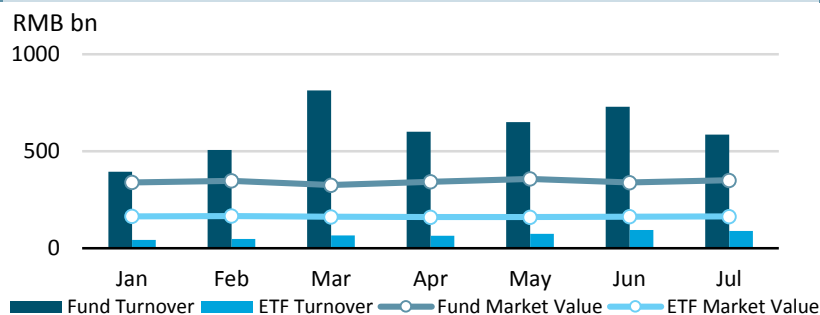

Bond Turnover, Outstanding & Issuance



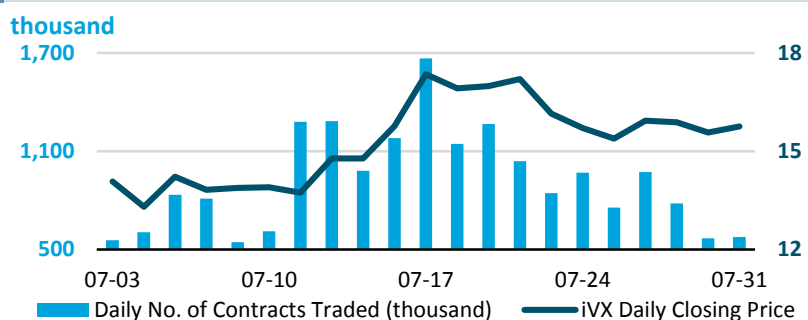
Fund Market

Turnover & Market Value



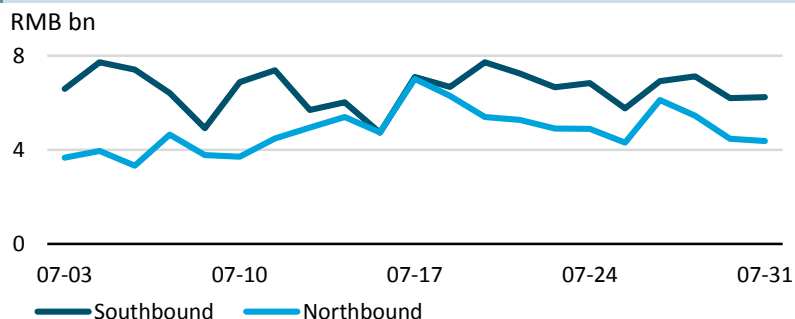

No. of Contracts Traded & iVX

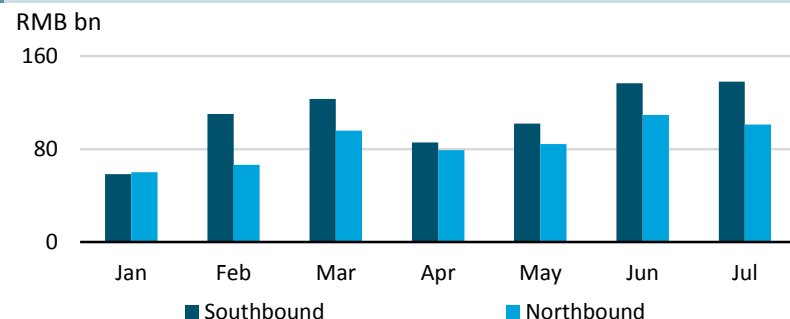

Daily Turnover

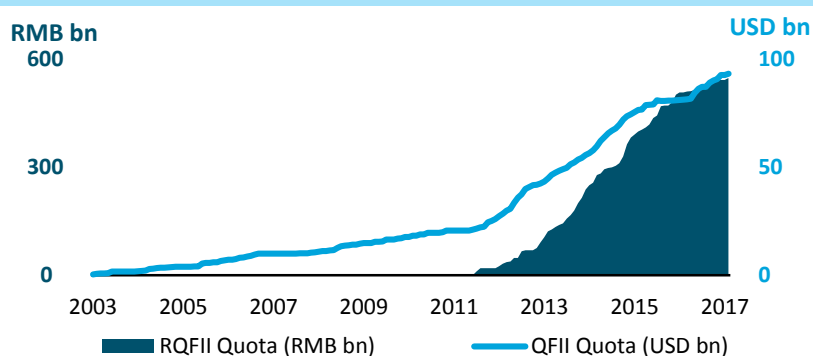
