SSE STAR 50 ETF Options Smoothly Launched

06 Jun 2023

The trading of STAR 50 ETF options on its first day of listing was steady and within expectation on the whole. There were a total of 144 listed contracts, including call options and put options, 4 expiry months (June, July, September, and December 2023) and 9 exercise price sequences. The total turnover in the whole day reached 309,900 contracts, including 171,500 call options and 138,400 put options; the premium reached RMB 79 million yuan, with a trading face value of RMB 3.442 billion yuan, and a total open interest of 161,100 contracts. Overall, on the first day of listing, the STAR 50 ETF options were reasonably priced, with steady market operation and rational participation by investors.

Securities Watchdog to Boost Investor Confidence

The China Securities Regulatory Commission vowed more measures on Thursday to enhance the quality of listed firms and strengthen crackdown over illegal transactions, which experts said is crucial for reinforcing investor confidence. "We are making every effort to provide investors with authentic and transparent listed companies," Yi Huiman, chairman of the CSRC, said at the two-day 14th Lujiazui Forum 2023 in Shanghai.

Yi said the commission will diligently implement a three-year action plan to improve the quality of listed companies and enhance the long-term, comprehensive regulatory mechanism with relevant parties to boost information disclosure quality and strictly crack down on misdeeds like financial fraud.

China's manufacturing PMI ends 3-month decline in June

The purchasing managers' index (PMI) for China's manufacturing sector ended a three-month decline in June, an encouraging sign of improving factory activities and strengthening economic momentum. The PMI came in at 49 in June, up from 48.8 in May, data from the National Bureau of Statistics (NBS) showed.




Shanghai A Shares (Main Board A & STAR Market) Market Cap & Trading Value

Index Performance & Equity Trading Value







Monthly IPO Proceeds (RMB bn)



STAR Market Sector Distribution (as of July 5)




STAR Market IPO Pipeline (as of July 5)



Daily Northbound Trading Value and Net Inflow (RMB bn)




Monthly Northbound and Southbound Net Inflow (RMB bn)


Monthly Total Market Value and Average Daily Trading Value (RMB bn)


Monthly Total Market Value and Average Daily Trading Value (RMB bn)
