

Monthly Review

- 8 companies listed on SSE in December, of which 3 are from strategic emerging industries, specializing in automated production equipment, hydropower and mold design.
- China and the U.K. agreed to accelerate the final preparations and to review, when conditions permit, the timeline for launching the London-Shanghai Stock Connect after the 9th China-UK Economic and Financial Dialogue.
- SSE, SZSE and CSDC released rules on pre-trade risk check for capital of securities trading, which will be implemented in June 2018.
- SSE revised 5 guidelines on formatting listed companies' temporary announcement to improve the accuracy of performance disclosure.
- SSE, Peking University, Renmin University of China and East China University of Political Science and Law co-held the 6th SSE Law Forum.
- SSE signed an agreement with Shanghai Hengshan Corp. to officially rent the Astor House hotel, where the Exchange opened to business in 1990, with a plan to turn it into multiple functions, one of which being the venue to host the 2018 Capital Market Exhibition.

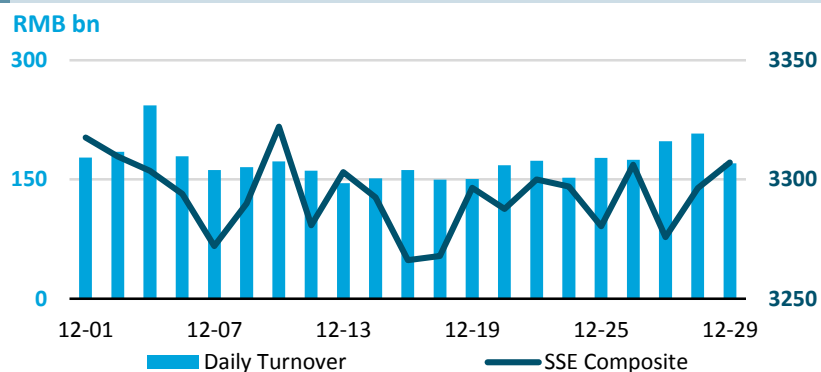

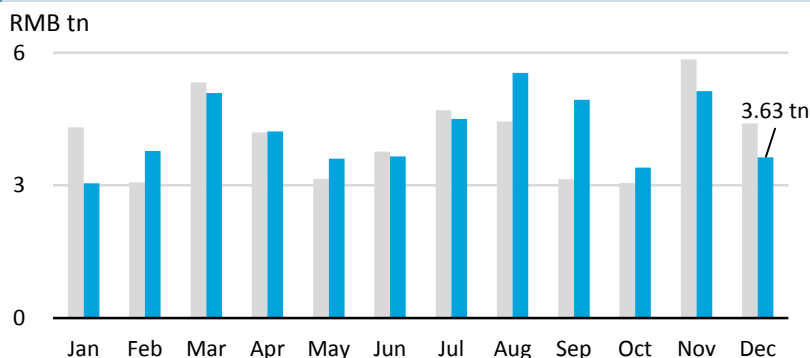

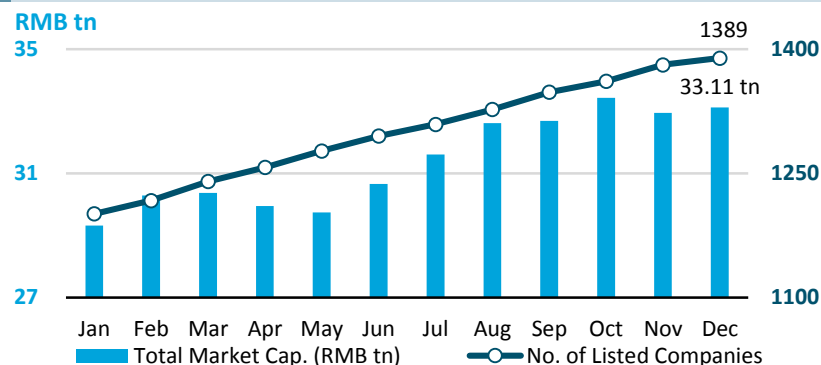
SSE Composite & Daily Turnover



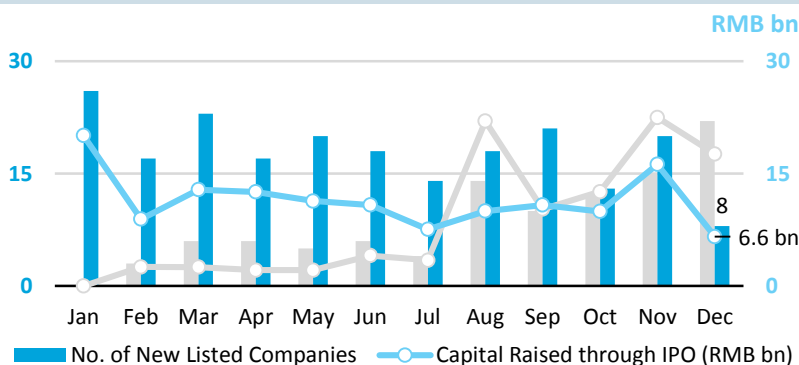
Monthly Turnover



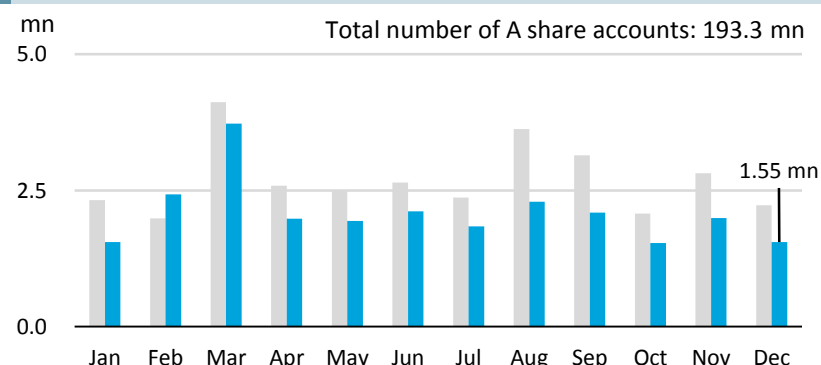
Market Cap. & No. of Listed Comps



Monthly IPO



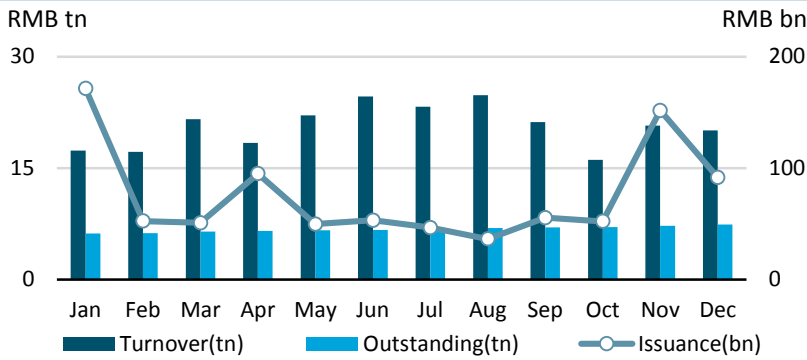
No. of New A Share Accounts

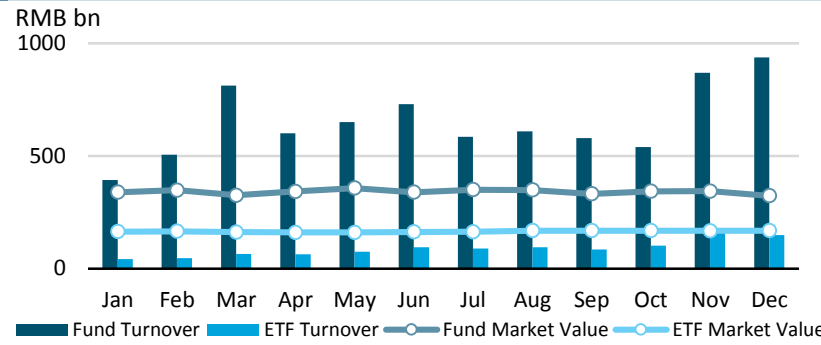

Bond Turnover, Outstanding & Issuance



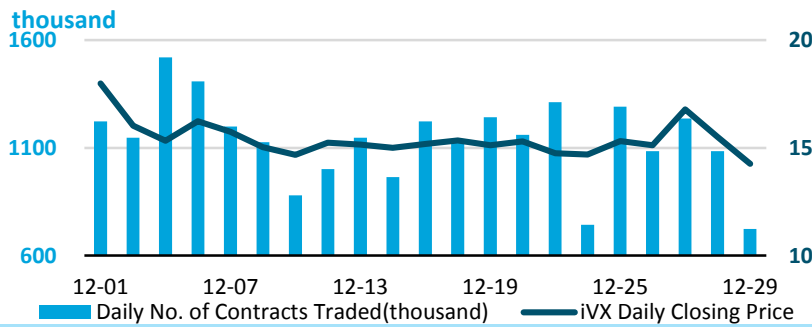

Turnover & Market Value

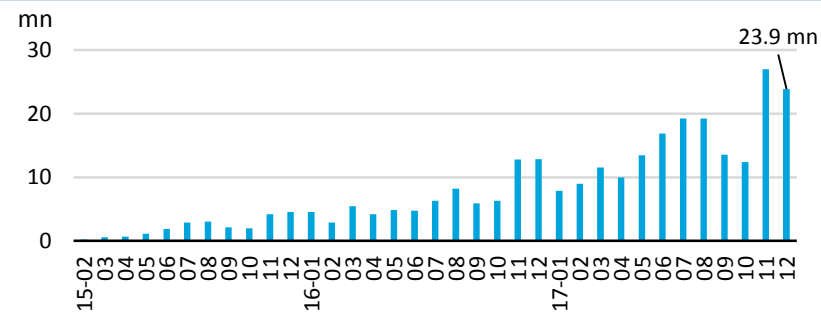


Derivatives Market (SSE 50 ETF Options)

Daily No. of Contracts Traded & iVX

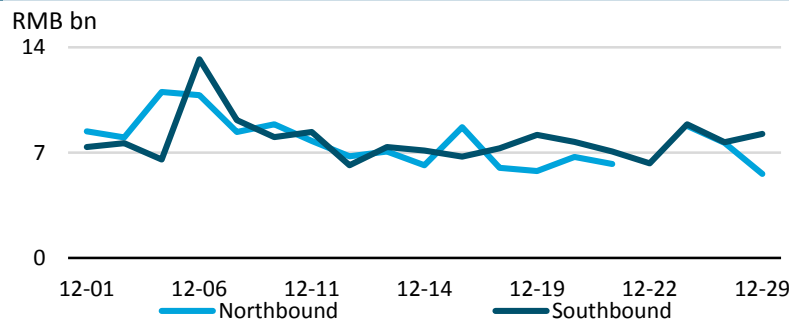


Monthly No. of Contracts Traded (since launched)

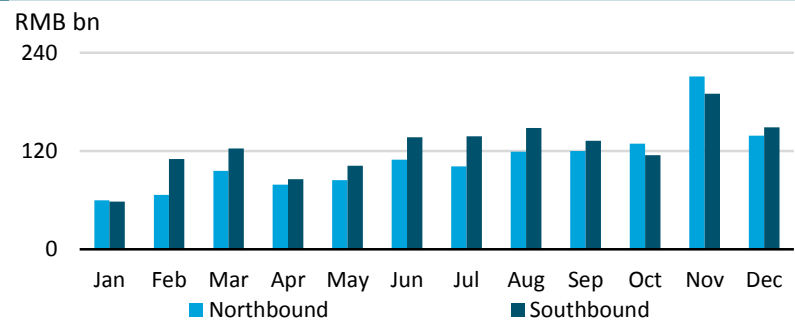

Daily Turnover

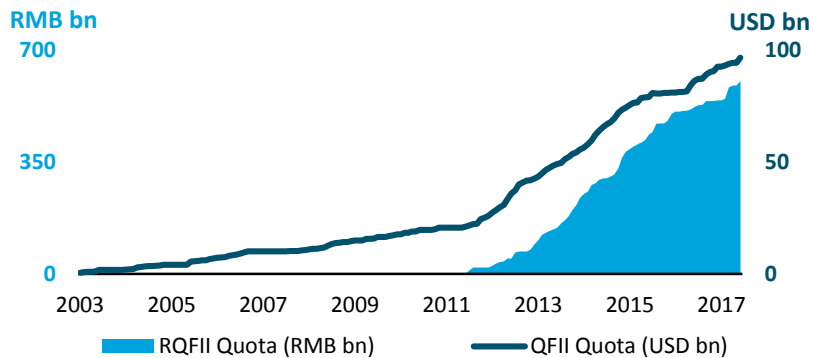


Monthly Turnover
